South Durham Gymnastics have a dedicated viewing gallery for parents/guardians to watch sessions and competitions from. The gallery, which is located on the first floor of the Gymnastics Centre, is accessible via stairs and lift – and is also home to the South Durham Diner.

We expect all visitors to conduct themselves in an appropriate manner whilst adhering to the **Parents**, **Carers & Visitors** section of our **Club Codes of Conduct**.

Anyone accessing our gallery - be it to watch gymnastics class, competition, festival, display/event or just to access the Diner - must adhere to the following rules:

### **PHOTOGRAPHY & VIDEO RECORDING**

- There is strictly **NO** photography/video recording of gymnastics/trampolining sessions allowed; this is to ensure the safety and safeguarding of all of our members
  - We appreciate that some parents/carers may wish to capture a photo/video for a relative, or even a school project – in this instance, please speak to a member of the coaching team for this to be arranged from within the gym (where we can appropriately safeguard other children)
- Photography/videoing is typically permitted at gymnastics competitions; however, this will be confirmed by the Competition Organiser before the event takes place
  - When photography/videoing is permitted, flash must be turned off

## **GYMNAST / PARTICIPANT SAFETY**

 Watching your child(ren) and seeing their progress can be an enjoyable experience, however, some children (especially younger children) can be very easily distracted - which can be dangerous for them. With this in mind, we request that you do not wave or intentionally try and get their attention by knocking on the windows during a session

### **VIEWING GALLERY SAFETY & CLEANLINESS**

- You (as a parent/carer) are responsibly for any siblings/other children that accompany you whilst
  visiting the Centre. They must be under your constant supervision at all times. Please ensure
  children do not knock on the windows, climb on the seating areas, or run around the building. All
  children must also be accompanied when using the toilets
- Please help us keep the gallery clean and tidy for other spectators by disposing of your rubbish in the bins provided
- Please report any issues in relation to spillages, cleanliness or breaks/damage to the SD Diner, or the Gym Office

## **SOUTH DURHAM DINER**

• Only food purchased at the SD Diner, or from one of the vending machines within the Gymnastics Centre should be consumed on the viewing gallery – we thank you for supporting us with this!

South Durham Gymnastics is happy to allow parents/carers to watch their child(ren) from the viewing gallery. However, if there are repeated incidents of not adhering to our **Viewing Policy** or **Codes of Conduct**, we will have no choice but to stop the individual(s) involved from watching their child's session/competition. In this situation, parents/carers will be invited in for a discussion with a Member of the Management Team (and Welfare Officer if required) to resolve the situation. Repeated violations or a serious breach may result in a permanent ban.
